The Museum of the Horseless Carriage cordially invites you to its inaugural “Celebration of Brass” event. A fun-filled, five-day program featuring a car show, swap meet, numerous on-site activities, and three days of touring the scenic country roads of western-lower Michigan. Included within you will find information to plan your trip, registration, waiver forms, and itinerary. What’s important for you to know is that our team and vendors are working hard to ensure all venues meet health and safety standards according to Covid-19 guidelines. Most locations and planned activities will be large open outdoor venues and there will be safe and ample space to park your transporters for the duration of your trip. There are a limited number of rooms in our group block at the Four Points Sheraton so it is recommended you register by April 15. Car tour participation is capped at 50 cars.

Eligibility

All automobiles (any number of cylinders, steam or electric), motorcycles, and bicycles made before 1916 are welcome. If you have any questions about eligibility or registration, refer to contact “inquiries” below; we are glad to help.

- For the Car Show and Swap Meet, you DO NOT need to be a member of the HCCA to participate.
- For the Car Tour, you DO need to be a current member of the HCCA.
